### DIRECTIONS TO HUNT TEST LOCATION

From Lansing (east): Take I-69 south towards Charlotte and take the Potterville exit. At the end of the ramp turn right and go a half mile on Hartel Road. Turn left on Vermontville Highway and go 6.5 miles to M50. Turn right on M50 and proceed 3 miles to Ash Highway (dirt road). Turn left on to Ash Highway and go a half mile and turn left on to Chester Road, go 0.2 miles to the second house on the right.

From Charlotte (south or west): Get on M50 going north and proceed for 8 miles to Ash Highway (dirt road). Turn left on to Ash Highway and go a half mile and turn left on to Chester Road, go 0.2 miles to the second house on the right.

From Ionia (north): Go south on M66 for 16 miles and turn left on M43. Proceed 1.3 miles to M50 and turn right. Take M50 south 9.4 miles and turn right on Chester Road, go 0.7 miles to our house.
